CLINIC/THERAPY SERVICES

OCCUPATIONAL THERAPY

Our New York State Licensed Occupational Therapists provide treatment sessions in the classroom and clinic. We work with each individual to help them develop small motor and visual-motor skills, selfcare skills including dressing, toileting and mealtime skills, and sensory processing for more functional participation at home, school and in the community.

PHYSICAL THERAPY

Our New York State Licensed Physical Therapists and Physical Therapist Assistants build on the movement skills an individual already possesses, seeking to diminish factors that interfere with functional movement.

SPEECH AND LANGUAGE PATHOLOGY

Our Certified and/or Licensed Speech/Language Pathologists provide both individual and group therapy sessions in the classroom and therapy settings. We work to assess, diagnose, and treat speech, language, social communication and feeding disorders in those we serve. Our therapists utilize a total communication approach to facilitate the client's ability to effectively express his or her wants and needs.

COUNSELING

HCA utilizes Licensed Social Workers to provide counseling to individuals.

RESIDENTIAL SERVICES

INDIVIUALIZED RESIDENTIAL ALTERNATIVES

HCA fully operates fifteen Individualized Residential Alternative homes across Broome County.

CHILDREN'S SERVIES

PRESCHOOL

Our integrated preschool programs at HCA nurture and teach children with special needs and their typically developing peers, offering an enriching and diverse environment for each student. Our Education philosophy is: ALL children can learn and their earliest years yield the most rapid growth and development. We partner with the Binghamton, Johnson City and Union-Endicott School Districts' Universal Pre-K (UPK) programs.

EVALUATIONS & SCREENINIGS

HCA is able to provide evaluations in the following disciplines: Early Intervention, Psychology, Child Development, Occupational Therapy, Physical Therapy, and Speech & Language. HCA can provide screenings for children up to five years old to determine if further evaluations are needed. HCA's Developmental Screening Program is a grant-funded program through the United Way of Broome County which enables our Child Development Specialists and Therapists to provide free developmental screenings for children ages $2\frac{1}{2}$ in area preschools and child care centers throughout Broome County.













INDIVIDUAL & FAMILY SUPPORT SERVICES

COMMUITY AND DAY HABILITATION

Our Community Habilitation and Day Habilitation programs provide services to enable individuals to live with the greatest degree of independence possible. An individualized plan is written, to facilitate community inclusion, integration, and relationship building in a community setting.

RESPITE SERVICES

Our Respite programs offer parents, families and caregivers time for a well-deserved rest by providing short-term care for individuals with developmental disabilities.

SELF DIRECTED SERVICES

Our Self Directed program is a person-centered approach for people with developmental disabilities that prioritizes individual choices, needs, and desires in making decisions.

SUPPORTED EMPLOYMENT SERVICES (SEMP)

HCA provides SEMP-intensive or extended pathways to employment, a one-time service to assist people to find the career path they would like to pursue in a 12-month period, as well as an Employee Training Program (ETP), where the state pays for the employees' wages while they work and build skills, with the goal of having the employer direct hire them at the end of the program





















AVA'S LITTLE HEROES

At a young age, Ava was diagnosed with a rare seizure disorder. With this prognosis, doctors suspected that Ava may never walk or talk. The Patch family learned that with a diagnosis such as Ava's, working with a Speech Therapist, Physical Therapist, and Occupational Therapist would help her reach her maximum potential.

HCA's Building Blocks Preschool has the resources and therapists to help children with a variety of needs. Ava was enrolled in the preschool programs at the Johnson City and Discovery Center locations, and together with her teachers and team of therapists, they created a plan to help Ava thrive. Now Ava is not only walking and talking, she is also dancing and singing!

The Patch family and Animal Adventure Park started "Ava's Little Heroes," a fundraiser to help kids like Ava. "Ava's Little Heroes" donated over \$40,000 for adaptive equipment to HCA. This adaptive equipment included modified pediatric parallel bars for our Physical Therapy and Occupational Therapy Clinic and accessible playground equipment. The pediatric parallel bars help to teach children with mobility problems how to stretch their limbs and put weight on their legs, which can lead to walking without the assistance of the parallel bars.

Kevin Ludwig, a Physical Therapist Assistant at the preschool, worked closely with Ava and developed a strong relationship with the family. Kevin and his family were involved with the installation of the donated equipment and talked with Jordan about what HCA means to him and the Patch family:

"We could not be more grateful for the positive experiences, education, and advocacy we experienced on behalf of Ava while attending and working with HCA. Our mission of inclusion at Animal Adventure Park & Preserve extends beyond our park gates, helping and serving the families of our community. Our ability to contribute and support is on behalf of our family, but made possible by the many that have supported Ava's Little Heroes, named after our very own hero!"

ENDICOTT SERTOMA CLUB DONATES TO SUPPORT HEARING HEALTH



Mary Summerville-Sabitus, MA, CCC/SLP has been a Speech Language Pathologist with HCA for over ten years. Throughout those ten years, Mary has impacted HCA in a variety of ways, one being spreading the HCA mission through her participation with the Endicott Sertoma Club. Mary has been a part of the Endicott Sertoma Club for 5 years and her participation in the club has translated into over \$14,000 in donations to HCA.

The Endicott Sertoma Club's purpose is to meet the needs of communities through volunteer service and to improve the quality of life for those at risk or impacted by hearing loss through education and support.

Mary attends weekly meetings and volunteers at events that raise funds for area agencies. The funds donated by the Sertoma Club helped to pay for the augmentative and alternative communication (AAC) devices, communication boards and Speech Language Pathology apps for communication.

DENTAL HYGIENE COLLABORATION LEADS TO AWARD

SUNY Broome Community College Dental Hygiene Program has partnered with HCA since 2017 to provide their senior students with an opportunity to engage with and provide services to individuals with intellectual and developmental disabilities of all ages. The program invites our nurses from HCA to speak to the students regarding specific needs, challenges and positive approaches to our individuals.

Over the course of several weeks, the individuals attend dental clinics where they receive special care and dental cleaning services. This provides a handson experience for the students, and a very positive exposure to dental care for our individuals.

The ongoing success of this partnership helped to gain the attention of the Cerebral Palsy Association of New York State, of which HCA is an affiliate organization. The SUNY Broome Dental Hygiene Program was selected as the 2022 recipient of the Program Innovation Award. The purpose of the award is "to recognize an Affiliate of the Cerebral Palsy Associations of New York State that has provided an exemplary program to people with disabilities that has enhanced the independence and self-esteem of its participants and which serves as a model to be replicated across the state." By winning this award, it is our hope that more colleges will see the benefit of partnerships like this and take steps to implement them into their curriculums.

This collaboration has been such a positive experience for all of the individuals that have attended these clinics. Under the expert supervision and role modeling of the instructors, the students provide dental hygiene services to the patients. Their calm approach and gentle technique helps overcome anxieties that the individuals may have, and they often end up joyful and expressing their enthusiasm for coming the next time!

The Residential Services Department oversees fifteen Individualized Residential Alternative (IRA) homes across Broome County that foster a supportive family atmosphere through 24-hour hands-on care. As part of the program, individuals are encouraged to become contributing members of their community. We encourage the values of helping others through volunteering, participation in group activities, and maintaining relationships. Individuals attend clubs, dances or craft groups and participate in classes of their choice.

Inside the Residential Department offices, a map of the world is marked with pins to show all the various places where staff are from; showing the wide range of countries and cultures our HCA family comes from. Over the summer, individuals in our residential homes had the opportunity to learn about each other's cultures and backgrounds through a food celebration. Staff created dishes that represented their home countries. Staff and individuals shared food and music while being able to gather together.

The countries represented included: Brazil, Cameroon, Columbia, Democratic Republic of Congo, Dominican Republic, Egypt, Guyana, Haiti, India, Iraq, Jamaica, Kenya, Kurdistan, Liberia, Mexico, Pakistan, Panama, Puerto Rico, Romania, Russia, Rwanda, Serbia, South Sudan, Sudan, Tanzania, Trinidad & Tobago, Uganda, Ukraine, and the United States.

- We are committed to act with integrity to each other and to those that we support.






